International and District New Member Add Fees should be paid in one check and mailed to Kiwanis International – along with the Membership Information Form for the new Kiwanian. ***Kiwanis International will transition to Graduated Dues – replacing the New Member Add fee - beginning in April 2010. Further information will be coming from Kiwanis International at a later date.***

## Common Billing Date

During the 2009 Kiwanis International Convention, the House of Delegates approved a common billing date for dues, which will be effective October 2010 for all U.S. Districts, Western Canada District, and Eastern Canada & Caribbean District.

The important thing to know is the changes will be effective **October 1, 2010**, not 2009. During the 2009-10 year, all billing processes and fees will remain as they have for the past several years.

Prior to October 1, 2010, we will provide additional information regarding the common billing date schedules.

### Brief Overview

#### **Clubs organized between September 1 and December 31 (Billing Group 1):**

Year 2010-11

- Payment based on club roster as of September 30, 2010
- Due October 1, 2010
- Payable no later than November 30, 2010

#### **Clubs organized between January 1 and April 30 (Billing Group 2):**

Year 2010-11

- Payment based on club roster as of September 30, 2010
- Due December 1, 2010
- Payable no later than January 31, 2011

Year 2011-12

- Payment based on club roster as of September 30, 2011
- Due October 1, 2011
- Payable no later than November 30, 2011

#### **Clubs organized between May 1 and August 31 (Billing Group 3):**

Year 2010-11

- Payment based on club roster as of September 30, 2010
- Due February 1, 2011
- Payable no later than March 31, 2011

Year 2011-12

- Payment based on club roster as of September 30, 2011
- Due December 1, 2011
- Payable no later than January 31, 2012

Year 2012-13

- Payment based on club roster as of September 30, 2012
- Due October 1, 2012
- Payable no later than November 30, 2012

Dear Kiwanis Leader:

Please read this memo carefully as it contains information to help you understand how the annual dues billing process will work, how to report new members and former members, and how much your club will be charged for the new members.

**ANNUAL DUES BILLING TIMETABLE**

As approved at the 2004 International Convention, annual dues billing of clubs will begin with the dues billing for the 2005-06 administrative year. Each club in United States, Canadian, and Caribbean districts will receive a membership roster to update, followed by an annual dues invoice according to the schedule noted below. This schedule assigns each club to one of three groups according to the club's anniversary date. This anniversary date and specific dates listed below will help inform you how the club reports and pays for new members and dues.

Group #	Club Anniversary Date	Date Membership Roster Sent to Club	Annual Membership Cut-off Date	Date Roster Due to Kiwanis International	Payment Due Within 30 Days But No Later Than
1	September through December	September 1	September 30	October 10	December 31
2	January through April	December 1	December 31	January 10	March 31
3	May through August	February 1	February 28	March 10	May 31

As noted in the table above, each club will have approximately 40 days to complete the roster and return it to Kiwanis International. It is very important to return your club's updated membership roster by the roster due date noted.

**NEW-MEMBER FEE UPDATE**

- Effective October 1, 2005, the new-member fee will officially change from US\$15 per new member to: Tier A, US\$50; Tier B, US\$25; Tier C, US\$15. All United States and Canada clubs are Tier A clubs.
- These new-member fees are for Kiwanis International only. Districts that have new-member fees will have a separate amount.
- **The date each new member is added to or deleted from a Kiwanis club, as entered in the Kiwanis membership database, will be determined by the date the new-member form or updated roster is received by Kiwanis International. Join or delete dates will not be backdated as has been previously done. This procedure will become effective immediately.**
